Principal's Report

The Principal's Report as issued earlier was presented and taken as read.

Financial Report

Monthly Reports

The Finance and Audit Subcommittee met this week to review in detail all the financial statements and operational reports.

The financial summary reports as issued earlier were presented and taken as read.

Anita briefed the Board on a funding proposal for kapa haka piupiu noting:

- Quotes are being requested for 22 piupiu for the kapa haka roopu.
- Piupiu are an artisan item which if looked after can last 20 or more years, however this makes them expensive. \$14,000 is the indicative cost for 22 piupiu at this point.
- Nicky Osmond is pursuing funding from Pub Charity for a proportion of the cost, but the school would need to fund 20-25% of the total cost to get the funding application over the line.
- The Kaipara Festival will generate revenue which can contribute to the piupiu cost if needed.

Motion: "That if the Pub Charity funding application for piupiu is approved that

the school will fund the remaining 25% of the cost up to a maximum of

2024 Final Accounts
